Treatment and packaging requirements for each type of sample:

1. GRAPES

- Samples must be frozen at -18°C or lower for a minimum of 24 h prior to transport.
- All samples must be securely packed in a double ziplock bag to prevent leakage.
- All samples must be placed in a durable container with ice packs to keep cool and prevent damage in transit.
- Each sample must have a label affixed with a unique sample description or code.

2. JUICE

- Samples must be frozen at -18°C or lower for a minimum of 24 h prior to transport.
- Samples must be placed in a sealed unbreakable container and packed in a double ziplock bag.
- Samples must placed in a durable container with ice packs to keep cool and prevent damage in transit.
- Each sample should have a label affixed with a unique sample description or code.

3. LEAVES/SHOOTS/CANES (for varietal ID only)

- Samples must be frozen at -18°C or lower for a minimum of 24 h.
- Samples must be securely packed in a double ziplock bag and shipped on **dry ice** to preserve their integrity. Please notify your courier in advance if you are using dry ice for transport. For alternative shipping options, please contact customer service.
- Each sample must have a label affixed with a unique sample description or code.


- A completed copy of this Plant Material Movement and Declaration Form, the CA12 certificate and any other required documentation (e.g. Phylloxera permit) must accompany the samples.
- **Please note:** Permits or certifications <u>may</u> be required by the **state of origin** to enable fruit to be moved out PIZ, and PRZ. Please contact the relevant branch or office of the local Dept of Primary Industries in your state to verify requirements. If a permit is required, it must accompany this consignment.
